*Buckden Parish Council strongly opposes the proposed closure of these roads. The closures and the proposed new road works should be delayed until a new road safety survey and analysis has been carried out on the proposed Stirtloe Lane/A1 junction by Highways England and the CCC Highways Division. Buckden Parish Council has requested this to be carried out as a matter of urgency and strongly recommends that no road works be started until the results are known, a full analysis carried out and a safer new Stirtloe Lane/A1 junction is designed and approved.*
